CPCCLRG3001A - Licence to perform rigging basic level is designed to provide participants with the ability to perform basic rigging, work safely and equip them with the knowledge and confidence to obtain a National High Risk Work Licence and a Statement of Attainment is issued

Pre-requisites

- CPCCLDG3001A - Licence to perform dogging
- Good verbal and written comprehension of the English language
- Photo ID
- 18 years of age or over

Duration of Course

- Course duration for training and assessment is 4 days

Training Location

- Face to face delivery.
- On-site training and assessment

Course Overview

- Training sessions will be carried out on site and in a classroom environment

Performance elements:

1. Plan work
2. Select and inspect equipment
3. Set up task
4. Erect structures and plant
5. Dismantle structures and plant

Language, Literacy & Numeracy

Allowances can be made for participants with language, literacy & numeracy issues.

You will complete a short literacy and numeracy assessment on enrolment and if we identify any learning difficulties the Trainer/Assessor will be notified prior to your attendance for the course.

Depending on your learning difficulty, the Trainer can spend extra time assisting you and/or do a verbal assessment with you. Or we may discuss options with you and may refer you to other support services as outlined in the Candidate Support, Welfare and Guidance Section on page 11 of the Student Handbook.

Course Cost

- Prices from \$699 per student
- Additional to this price a fee is also payable to Australia Post for the license card which is nationally recognised.

Once the SafeWork (or relevant safety authority) assessment has been successfully completed, you will receive a SafeWork (or relevant safety authority) Notice of Satisfactory Assessment (MSA) which is valid for 60 days. A fee is payable to Australia Post for the license card which is nationally recognised.

Certification

- All participants that successfully complete the course will be issued with a statement of attainment. This unit of competency is nationally recognized.
- Once the SafeWork (or relevant safety authority) assessment has been successfully completed, you will receive a SafeWork (or relevant safety authority) Notice of Satisfactory Assessment (MSA) which is valid for 60 days. A fee is then payable to Australia Post for the license card which is nationally recognised.

RPL

RPL recognises that people who already have the knowledge and skills required for competency in various elements of units of an accredited training package should not be required to re-learn what they already know. The process of RPL also takes into account that various competencies can be acquired through:

- previous qualification,
- work experience and
- Life experience.
- Video evidence
